

The 2010 Orange County Summer Music Institute

What is it? A two-week full band, chorus, and string ensemble experience culminating with a free public concert. Perform great music with students from Orange County.

Who is eligible? Band and string students with two or three years of performing experience (or one year experience with a NYSSMA score of "Excellent" or "Outstanding" on a Level One solo) are eligible for the Intermediate ensembles. Students with four or more years of experience are eligible for the Senior ensembles. **Chorus students** entering the 4th through 7th grade are eligible for the Intermediate Chorus. Students entering the 8th grade or higher are eligible for the Senior Chorus.

How much does it cost?

Early Registration: \$80/student (~~May 31~~ Extended! postmarked by June 5)
Regular Registration: \$95/student (before June 24)
Late Registration: \$110/student (June 25 and after)

How can I get a discount? Any student who brings (an) additional first time, new participant(s) to the program will receive a \$20 discount per new participant on their own registration fee up to full tuition (no payment for discounts beyond the full tuition). Eg. A family with 3 children who will be attending the SMI for the first time will be discounted \$40 off of the total registration). Registration forms and payment for all involved parties must be received together in order to receive the discount.
